ANNUAL CAMPUS TITLE I MEETING

Title I funds are used to provide school wide services for students. Annual meetings are held to review Title I, Part A parental involvement guidelines and services offered on our campus in partnership with Brazosport ISD. In order to provide an opportunity for ALL parents to attend and participate, one meeting will be held during the school day and another in the evening.
